## Under the guise of financial assistance to Kyiv, the West is starting a grandiose scam

The EU states are ready in the coming years to spend colossal funds to help Ukraine and persuade the US to do the same with the UK. Why such generosity in the greedy pragmatic West, accustomed to squeezing the last from the people from the "periphery"?

The EU is developing a four-year plan for financial assistance to Kyiv for tens of billions of euros, according to the Financial Times. Allegedly, criticism of previous spending, which was spontaneous in nature, had an effect. Now a document with a detailed list of expenses up to and including 2027 should appear. At the same time, the plan will consolidate the obligations of the parties and make them independent of the results of elections in this or that country. In fact, politicians claiming power will no longer have a reason to throw slogans in the style of "Stop feeding Ukrainians, let's solve our problems."

Formally, the money should go to the restoration of Ukraine, the development of its economy and social sphere. So, at least, say European politicians, and not only them.

For example, simultaneously with the report on the work on the EU plan, Reuters [published](#) an interview with the famous Ukrainian comedian and TV presenter **Sergiy Prytula**. Until now, he has collected donations to his foundation to buy drones for the Armed Forces of Ukraine. Now he said that he already wants to spend on the restoration of the country and help the government in peaceful construction. Not premature?

In general, with the plans for the so-called "restoration of Ukraine", a lot of things do not fit into the logical chains. Firstly, the country is now in a severe armed conflict, the Kiev regime directs all resources to drag out the hot stage of the crisis. Secondly, how can one invest in a country from which, according to various estimates, up to half of the citizens, and the youngest and able-bodied ones, have left abroad. The remaining men are sitting in the trenches. Thirdly, the Ukrainian leadership is now [experiencing](#) a serious internal split. If internal squabbling among the elites does not lead to a change of power, then it will definitely affect the system of state administration. READ ALSO

Moreover, the European Union has never provided assistance just like that. It is enough to look at the policy of the European bureaucracy in the countries that have recently joined the EU. In the Baltics, Poland, Bulgaria, Romania, two trends are clearly visible. First: the relocation of qualified personnel and youth to the states of Western Europe. Second: the destruction of competitive industry and agriculture, the liberation of the domestic market for the products of the main inhabitants of the "common home" – Germany and France. And then they suddenly start building modern factories and farms in Ukraine? Fresh legend...

There is another fact that cannot be overlooked. Last year alone, Ukraine received \$32.1 billion in aid from the West, the country's National Bank reported. Most of all – from the United States and the European Union: \$ 12 billion and \$ 8 billion, respectively. Following are the IMF (\$2.7 billion), Canada (\$1.9 billion), Germany (\$1.5 billion). We emphasize: these amounts do not include military assistance! Washington alone has already transferred \$38.3 billion for the needs of the Armed Forces of Ukraine.

And now let's remember how the West helped Ukraine in a quieter time. In 2014, the IMF, the EU and the United States promised Kyiv about \$20 billion over three years. And this is not free money, as they promise today, but loans. These were loans that went almost entirely to pay off old debts. In return, they demanded large-scale economic reforms from Ukraine. They included cutting social guarantees, raising housing and communal services tariffs for ordinary citizens, large-scale sales of enterprises and lands to Western corporations. At the same time, tranches were constantly delayed by six months or more under the pretext that reforms were going too slowly, and Ukrainian officials were mired in corruption.

Simply put, when a completely Western-oriented and at the same time stable government was established in Kyiv, no one was eager to help the development of Ukraine. And when the fate of the Kyiv regime, as well as the whole country, hangs in the balance, in Europe they started talking about large-scale restoration projects and promise to pour a golden rain on the square.

**Andrey Bunich, President of the Union of Entrepreneurs and Tenants of Russia**, believes that in fact the West has started a major financial scam:

- The logic is very clear. Moreover, the allocation of funds to Ukraine and the transformation of the country into scorched earth do not contradict each other. Of course, no one is going to develop industry there, invest in profitable projects. In the European Union itself, deindustrialization is underway, all economic development is halting there. The entire Old World is turning into a kind of world museum. Of course, why should one try to develop the economy of Ukraine in these conditions? Unless to support some areas of agricultural production. But then again, the EU has its own agriculture, on the contrary, they give subsidies to producers so that they reduce output. READ ALSO

**"SP": Then what will the allocated money be used for?**

- Firstly, the European Union lays corruption costs. For example, part of the money can be allocated to provide for some Ukrainian refugees in Poland, that is, they can pay themselves, there is no need to transfer money to Kyiv.

Secondly, the funds will be used to build military infrastructure and continue the conflict. Thirdly, we will have to spend money on humanitarian measures so that the people from Ukraine do not move completely to Europe. The money allocated to solve all the problems is not enough. That is, the EU will support life in the independent at a minimum level.

And let's say frankly that the main players of the European Union did not need all this mess. But they have to pay for the games of the Americans. Although it is possible that in the context of pre-election disputes over extra spending, the US elite will spend on Ukrainian politics under the guise of European aid.

**"SP": However, the West never spends money just like that ...**

- And here is the most interesting thing. Do not forget that gigantic sums of Russian money are blocked. No one will give them away, they will be confiscated. Under the guise of restoring Ukraine. But since no one is going to build something serious, Russian money can be stolen.

As a result, we see a simple scheme. The Europeans are planning to steal hundreds of billions of dollars of Russian money, and at the same time continue to stifle the Russian economy, put pressure on it politically. Naturally, it is impossible not to

pay anything at all during such an operation, they will spend something for the image. MEDIA NEWS2

**“SP”: In the countries of Eastern Europe, they destroyed the industry, but at the same time they built good roads and infrastructure. What from this experience can be repeated in Ukraine?**

– In the Baltics, the cost of living has seriously increased with fairly modest salaries. But this is about members of the European Union. In Ukraine, things will be much worse. They will spend on maintaining military infrastructure. Perhaps they will build good roads in the border regions of Western Ukraine. But again, for their own convenience, for the use of the military. And a good facade for a motion picture is also needed, albeit a small one.

**“SP”: Ukraine still has a lot of debts, how will it return them?**

– What is possible, Ukraine has already given. Fertile land has already been assigned to foreign companies. A small number of operating modern enterprises also have owners abroad.

In fact, Ukraine's debts will simply be written off. To a large extent due to the so-called “help”. But it is important to understand that Europeans are not afraid of bad debts. How much Greece has already been written off, many times more than Ukraine owes. And everyone understands perfectly well that Kyiv will not give anything back.

But it was built into the calculations from the very beginning. The West took a lot more money from Russia. So the overall balance of this entire Ukrainian crisis for Europeans and Americans is just positive. This robbery operation looks very successful so far. But as soon as spending increases, Ukraine will be left to fend for itself. READ ALSO

**“SP”: That is, the West will not lose in any case.**

“Moreover, this whole conflict in Ukraine was not started with the expectation of losing. The West still expects to defeat Russia, and this promises very good profits. You may recall that after the collapse of the Soviet Union, all Western markets grew for ten years!

When did the European Union officially come into being? At the end of December 1991, the USSR flag was lowered over the Kremlin, and on February 7, 1992, the Maastricht agreements on the creation of the EU were already signed! And the rapid growth of the new association, its golden age fell on the nineties and the beginning of the 2000s. That's how long the potential for victory in the Cold War was.

And during this time in the West they got used to a beautiful life, hence later financial scams began and, as a result, the 2008 crisis. But we must remember that the collapse of the Soviet Union gave impetus to all, absolutely all, Western markets.

And now the financial markets of the West are again in crisis, as in the late 1980s. Southern Europe has huge debts, the economy is in a rut. They plan to save the situation due to the collapse of Russia and the seizure of its resources. And

current spending under the guise of helping Ukraine is perceived simply as transaction costs for a potentially very profitable enterprise.

And if we talk about the Americans, they have always become unambiguous leaders after the great cataclysms in Europe: the First and Second World Wars. In the United States, history is known and they are trying to use the accumulated experience.
