The Zionists delayed their ground operation in Gaza because they are well aware that when they step foot in Gaza they will be going to their graves.

Along with Hezbollah opening a northern front, there is no way out for the Zionist entity except US intervention.

Many point to the 'Samson option' which is the idea that the Zionist entity will use nuclear weapons before being destroyed. Personally, I think this is a complete bluff, and I will explain why:

'Israeli' nuclear deterrence is a form of psychological warfare used to project power. But actually using nuclear weapons would severely compromise the entire international spider-web that Israel is only a piece of.

Zionist ideology is just a tool, a type of fascist terrorism, that is not actually rooted in any authentic belief whatsoever. The elites who have a vested interest in the Zionist entity would definitely choose self-preservation over self-destruction for this 'cause.'

As is well known, Israel is a creation of the British Empire. It is also an heir to this shadow Empire, built during the cold war - which encompassed secret ill-gotten fortunes of capitalist elites, Nazi mercenaries, Gladio stay-behind networks, right-wing death squads, fascist dictatorships, apartheid South Africa, Rhodesia and many other criminal postwar elements.

It forms an important part of the international spider web of off-shore Bank accounts, money-laundering, diamond trade, and derivative financial capital which maintains the system of unipolarity.

(Aka British Empire 2.0)

The elites within 'Israel' are thus ultimately loyal to this Empire above all else. Sure, there are some fanatical elements, especially among settlers, who would die for the Zionist cause. But ultimately, the criminals in power within Israel would rather choose self-preservation.

So if the Zionist entity is on the brink of collapse, and America doesn't intervene - they will choose a life raft, flee to safer ground, and plan for an offensive against the region.

Much of this hinges on popular opinion. It was only after the pressure of the Soviet Union, Africa, Latin America and Asia that the US and Britain finally decided to allow South African

apartheid to dissolve. This also allowed them to negotiate the terms of dissolving it in a way favorable to the De Beers and other capitalist elites.

We will likewise witness a similar situation in Israel's case: When the Zionist state collapses, the forces behind Zionism (unipolar capitalist elites) will try to renegotiate new terms, likely in collaboration with Saudi Arabia, so that at least the important assets of the network can be partially preserved.

This is why Iran is such a threat to the unipolar system. Iran is trying to promote a vision of genuine regional power sovereignty - both political AND economic. If Iran helps dictate the terms of Israel's collapse, then the Levant, and even region at large will become entirely disaligned with the unipolar system.

So I predict they will opt for a different 'Samson option:' Renegotiating Zionism.

When the Zionist entity is on the brink of collapse, it will quickly sue for peace - with international mediation. The Palestinians will gain a type of joint-sovereignty and unprecedented concessions.

It will be like the British mandate again, except with a force of 'global' peacekeeping occupation, and a new ground for proxy political conflict between international and regional powers.

This is my realistic assessment of how Israel's collapse would look like, not what I think should happen personally. I am obviously in favor of sovereign, regional powers, and the creation of integrated large states instead of stupid, shitty small ones.

But the Zionists (or should I say, the interests of the atlanticist powers) could definitely worm their way out of a total collapse, without using nuclear weapons.
